NOTIFICATION

The Admission Committee for Under-Graduate Studies of Bankura University in its meeting dated 22.05.2019 has approved the said recommendations for implementation/execution in the undergraduate colleges for admission procedures in the session 2019-2020. The recommendation pertaining to admission related different issues are as follows:

CHOICE BASED CREDIT SYSTEM:

1. Choice Based Credit System will be maintained for the academic session 2019-20.

PROCEDURE OF ADMISSION:

1. Necessary advertisement for on-line admission to the undergraduate course(s) for the academic year 2019-20 will be made by the respective undergraduate colleges of their own.
2. The entire admission process should be made online.
3. Documents to be uploaded by the students while filling up the online application:
 - a. Admit card and Mark-sheet of Madhyamik Examination.
 - b. Mark-sheet of Higher Secondary Examination.
 - c. Caste Certificate (where necessary).
 - d. PH Certificate (where necessary).
4. All orders & notifications issued by the State Government and G.O. N.O. 804-Edn(CS)/10M-95/14 dated 13.05.2019 are applicable in matters of admission and reservation rules.

Eligibility:

- a. Honours Degree Course:**
All candidates who have obtained at least 45% marks in 10+2 examination are eligible to apply for the Honours Degree Course.
- b. Programme Course:**
All pass candidates are eligible to apply for the General Degree Course.

N.B.:

1. Only Students who have passed with Mathematics as one of the subjects at the Class X01 level are eligible for admission to B.Sc. Honours Course in Economics and Computer Science.
2. Only Students who have passed with Chemistry as one of the subjects at the Class XII level are eligible for admission to B.Sc. Honours Course in Microbiology and Nutrition.
3. The Candidates who have passed the Vocational Course at 10+2 examination are eligible for admission to B.A. (General)/ B.Com. (Honours & General).
4. In case of equal marks in H.S. results, total marks/percentage of marks of immediately preceding examination is to be taken into account for ranking.
5. Best five (5) of the H.S. Subjects must be adopted for calculating the total marks and percentage.

Reservation of Seats:

Reservation of seats will be made as per norms of the West Bengal Government-SC (22%), ST (06%), OBC-A (10%), OBC-B (7%), differently abled candidates 3% of each category (GEN/SC/ST/OBC-A/ and OBC-B). For differently-abled candidate minimum disability of at least 40% will be considered.

Session Gap:

For admission to the Under Graduate Course, there should not be a gap of more than 3 years between the year of Higher Secondary Examination and the year of admission to Under Graduate Course of study. In respect of calculation of marks, no deduction should be made in case of candidates passing out in previous years.

Intake:

The intake capacity of the subjects will remain the same as in the previous year (2018).

Vocational Course:

Students who have passed Vocational Engineering and Technology (with pass marks in Mathematics) equivalent to 10+2 are eligible for admission to Computer Science and in Pure Science or Arts in the General Course in the First Semester. Those who have passed without Mathematics or without securing pass marks in Mathematics are for admission to Arts in the General Course.

Students who have passed Vocational Agriculture equivalent to 10+2 are eligible for admission to Science or Arts in the General Course.

Students who have passed Vocational Business and Commerce equivalent to 10+2 are eligible for admission to Commerce or Arts and Commerce (Honours).

Students who have passed Vocational Home Science equivalent to 10+2 are eligible for admission to Arts in the General Course.

Students who have passed in the Vocational Course are eligible to First Semester in the subject concerned in the college in 10% seats out of total number of seats on the basis of highest marks scored. In this case, they will have to score higher marks than the lowest marks scored by a candidate from the general board appearing in the list of successful candidates.

The Principal/O.I.C./T.L.C of the concerned undergraduate colleges are being informed accordingly and requested to follow the guidelines framed by the University in this regards strictly.

1	<p>PREAMBLE:</p> <p>In exercise of the powers conferred by sub-section (2) of section 58 of the Bankura University Act, 2013 (West Ben. Act XIX of 2013), the University of Bankura hereby makes the following Regulations, namely:-</p> <p>Note: These regulations are prepared as the Choice Based Credit System (CBCS) is introduced in Under Graduate course of studies and examinations from the academic year 2017-18.</p>
2.	<p>SHORT TITLE, APPLICATION AND COMMENCEMENT:</p> <p>These regulations may be called The Bankura University regulations: "Regulation relating to UG course of studies & examinations"</p> <p>These shall come into force with the passing of the same by the Executive Council of the University and the earlier notes/regulations in the relevant matter of examination for the students admitted during or after 2017-2018 academic year are being repealed. Notwithstanding anything contained in any other rules or regulation in force relating to UG course of study & examination of Bankura University and its affiliated colleges for the students admitted during or after 2017-2018 academic year shall be guided by these regulations.</p>
3.	<p>DEFINITIONS:</p> <p>In this regulation following definitions have been incorporated</p>
3.1	"University" means Bankura University established and incorporated under the Bankura University Act, 2013 (West Ben. Act XIX of 2013)
3.2	"College" means Non-Government College/ State aided college/ Government college / Minority college affiliated to this University.
3.3	"Under Graduate Course of Study" '(UG)' means a three year course of study divided into six semesters, each of six months duration after successful completion of 10+2 examination.
3.4	"Academic year" means the period from July to June.
3.5	"Year" means the period commencing from 1st day of July and ending 30th June following.

3.6	"Semester" means a period of six months beginning from July to December and January to June of each academic year containing at least 90 actual teaching days.
3.7	"Credit" means the unit by which the course work is measured. It is equivalent to one hour of teaching (Lecture or Tutorial) or two hours of Practical work/Field work per week.
3.8	"Letter Grade" means an index of the performance of students in a said course. Grades are allotted by letters O, A+,A,B+,B,C,P and F, and Absent will be stated as 'Ab'
3.9	"Grade Point" means a numerical weight allotted to each letter grade on a 10 point scale.
3.10	"Credit Point" means the product of grade point and number of credits for a course.
3.11	"Semester Grade Point Average (SGPA)" means a measure of performance of a student in a semester. It is the ratio of total credit point secured by a student in various courses registered in a semester and the total course credits taken during that semester. It shall be expressed up to two decimal places.
3.12	"Grade Card or Transcript" means a certificate issued to all registered students after every semester displaying the course details along with SGPA of that semester.
3.13	"Cumulative Grade Point Average (CGPA)" means a measure of cumulative performance of students over all semesters. It is the ratio of total credit points secured by a student in various courses in all semesters and the sum of the total credits of all courses in all semesters. It is also expressed up to two decimal places.
3.14	"Enroll" means enrollment of a student for appearing at first Semester final examination.
3.15	"Executive Council" means Executive Council of the Bankura University.
3.16	The Words and Expressions used but not defined shall be interpreted to have the

4.	COURSE OF STUDIES:	
4.1		There shall be two courses of studies leading to BA/BSc/BCom Degree and each course shall be of six semester's duration. One shall be termed as "B.A./B.Sc./B.Com. Honours Degree Course" and the other is "B.A./B.Sc./B.Com. Programme Course".
4.2		The admission to UG Degree programs will be governed by the guidelines of the University and the H.E department of Govt. of West Bengal as framed time to time.
4.3		A Candidate shall be allowed to pursue any one of the Undergraduate Degree programs of the University (not more than one) at a time.
5.	TYPE OF COURSES:	
5.1		Core Course (CC) of 6 Credits each: A course, which should compulsorily be studied by a candidate as a core requirement is termed as a Core Courses.
5.2		Elective Course (EC) of 6 Credits each: A course which can be chosen from a pool of courses and which may be very specific or specialized or advanced or supportive to the discipline or which provides an extended scope or which enables an exposure to some other discipline/ subject/ domain is called an Elective Course.
	5.2.1	Discipline Specific Elective (DSE) Course of 6 Credits each: An elective course offered under the main discipline/subject of study is referred to as Discipline Specific Elective.
	5.2.2	Generic Elective (GE) Course of 6 Credits each: An elective course chosen from an unrelated discipline/subject is called a Generic Elective. The list provided under this category are suggestive in nature and each university has complete freedom to suggest their own

	5.3	Ability Enhancement Course (AEC)	
		5.3.1	Ability Enhancement Compulsory Course (AECC) of 4/2 Credits: AECC are the courses based upon the content that leads knowledge enhancement i) Environmental Studies (4 Credits) and ii) English/Hindi/Modern Indian Language (MIL) communication (2 Credits). These are mandatory for all disciplines.
		5.3.2	Skill Enhancement Courses (SEC) of 2 Credits each: SEC are value-based and/or skill-based and are aimed at providing hands-on-training, competencies, skills etc. These courses may be chosen from a pool of courses and should contain both theory and la/hands-on/training/field work.. The purpose of these courses is to provide students life-skills in hands-on mode so as to increase their employability.
6.	IMPLEMENTATION:		
	6.1	Honours (B.A./B.Sc./B.Com): An undergraduate degree with Honours in a discipline may be awarded if a student completes 14 core papers of 6 credits each in that discipline, 2 Ability Enhancement Compulsory Courses (AECC), minimum 2 Skill Enhancement Courses (SEC) and 4 papers each from a list Discipline specific Elective and Generic Elective papers, respectively.	
	6.2	Programme Course (B.Sc.): An undergraduate degree in Science disciplines may be awarded if a student completes 4 core papers each in three disciplines of choice, 2 AECC, minimum 4 SEC and 2 papers each from a list of Discipline Specific Elective papers based on three disciplines of choice selected above, respectively.	
	6.3	Programme Course (B.A./B.com): An undergraduate degree in Humanities/ Social Science/Commerce may be awarded if a student completes 4 core papers each in two disciplines of choice, 2 core papers each in English and Hindi/ MIL, respectively, 2 AECC, Minimum 4 SEC, 2 papers each from a list of DSE papers based on the two disciplines of choice selected above respectively, and two papers from the list of Generic Electives

A report along with a copy of the said Diary and a statement from the Invigilator of the concerned examination hall must be sent by the Centre-in-Charge to the Controller of Examinations.
17.9	Torn scripts – In case of a script being willfully torn by a candidate, the fact should be noted in the Attendance Sheet(s) and a report should be sent by the Centre-in-Charge to the Controller of Examinations in a separate packet along with the torn script and a statement from the Invigilator of the concerned examination hall stating the circumstances leading to the incident.

NOTIFICATION

The Admission Committee for Under-Graduate Studies of Bankura University in its meeting dated 6th June 2023 along with Principal/OIC/TIC of the affiliated colleges under Bankura University and Members of the Core committee for implementation of New Curriculum and Credit Framework have approved the guidelines for implementation/execution in the undergraduate colleges for admission procedures in the academic session 2023-24. The guidelines pertaining to admission related different issues are as follows:

1. Curriculum and Credit Framework for Undergraduate Programme (CCFUGP):

New Curriculum and Credit Framework for Undergraduate Programme, UGC 2022 (as per NEP 2020) for 4-years undergraduate programme(s) with “UG Degree Programmes with Single Major” only will be maintained for the academic session 2023-2024.

2. Procedure of Admission:

- i. Necessary advertisement for on-line admission to the Undergraduate (UG) Programme for the academic session 2023-2024 will be made by the respective undergraduate colleges of their own (Standalone mode) as per the notification issued by the Government of West Bengal (vide N.O.354- Edn(CS)/10M-95/14, dated 2nd June 2023). Online admission will be made w.e.f 01/07/2023 and be completed by 31/07/2023. The colleges will provide all the information related to the admission for Undergraduate Programme along with a helpline desk (time specific) through mobile/ email in their website in this regard.
- ii. The entire admission process should be made online, strictly based on merit. Prospective students should not be called for counseling or verification of documents during the process of admission. No physical presence will be required at the College / University.

- iii. Documents to be uploaded by the students while filling up the online application:
- Admit card and Mark-sheet of Madhyamik Examination.
 - Mark-sheet of Higher Secondary Examination.
 - Caste Certificate (where necessary).
 - PH Certificate (where necessary).
- iv. All orders, notifications/Extant Rules issued by the Government of West Bengal including the notification vide N.O.354- Edn(CS)/10M-95/14, dated 2nd June 2023 are applicable in the matters of admission and reservation rules.
- v. As per New Curriculum and Credit Framework for Undergraduate (UG) Programme, UGC 2022 (as per NEP 2020), the Undergraduate Degree Programmes are of either 3 or 4-year durations, with multiple entry and exit points and re-entry options, with appropriate certifications such as :
- a UG certificate after completing 1 year (2 semesters) of study in the chosen fields of study, provided that a vocational course (additional 4 credits) must be completed during the summer term by the students who will exit the programme after securing 40 credits. These students are allowed to re-enter the degree programme within three years and complete the degree programme within the stipulated maximum period of seven (7) years.
 - a UG diploma after 2 years (4 semesters) of study provided that a vocational course (additional 4 credits) must be completed during the summer term by the students who will exit the programme after securing 82 credits. These students are allowed to re-enter the degree programme within three years and complete the degree programme within the stipulated maximum period of seven (7) years.
 - a bachelor's degree after a 3-year (6 semesters) programme of study,
 - a 4-year bachelor's degree (Honours) after a 4-year (8 semesters) programme of study. If the student completes a rigorous research project in their major area(s) of study in the 4th year of a bachelor's degree then (Honours with Research).

3. Eligibility for the UG Programmes:

Entry requirement for 1st year 1st semester is successful completion of 10+2/ Higher Secondary (12th Grade) or equivalent stage of education from any recognized Board/Council/University.

N.B.

- Only Students who have passed with Mathematics as one of the subjects at the Class XII/10+2 or

equivalent level are eligible for admission with major in Economics and Computer Science.

- ii. In case of equal marks in H.S. results, total marks/percentage of marks of immediately preceding examination is to be taken into account for ranking.
- iii. Best five (5) of the H.S. Subjects must be adopted for calculating the total marks and percentage.
- iv. In case wherever only Four (4) subject are offered by any recognized Board/Council etc, as the case may be in H.S or equivalent examination, first Language will be doubled to prepare the merit list on the basis of best five of H.S subjects as stated earlier.

4. Reservation of Seats:

Reservation of seats will be made as per norms of the West Bengal Government-SC (22%), ST (06%), OBC-A (10%), OBC-B (7%), EWS (10%), for differently-abled candidates 5% of each category. For differently-abled candidate minimum disability will be considered as per Government rule.

5. Session Gap:

For admission to the Under Graduate Programme (1st year, 1st semester), there should not be a gap of more than 3 years between the year of Higher Secondary/10+2 or equivalent Examination and the year of admission to Under Graduate Programme of study i.e 2021, 2022 and 2023. In respect of calculation of marks, no deduction should be made in case of candidates passing out in previous years.

6. Intake:

The intake capacity will be notified by the respective colleges as sanctioned by the appropriate authority.

7. Vocational Course:

Students who have passed Vocational Engineering and Technology (with pass marks in Mathematics) equivalent to 10+2 or equivalent level are eligible for admission to Science or Arts in the First Semester. Those who have passed without Mathematics or without securing pass marks in Mathematics are eligible for admission to Arts.

Students who have passed Vocational Agriculture equivalent to 10+2 or equivalent level are eligible for admission to Science or Arts.

Students who have passed Vocational Business and Commerce equivalent to 10+2 or equivalent level are eligible for admission to Commerce or Arts.

Students who have passed Vocational Home Science equivalent to 10+2 or equivalent level are eligible for admission to Arts.

8. For BCA:

- i) The candidate must be Indian National.
- ii) Candidates must have passed the Higher Secondary Examination of West Bengal Council / I.S.C. Examination / C.B.S.E. Examination / Any other equivalent Examination each under (10+2) or equivalent level system of studies, as the case may be, with English as one of the combination subjects.
- iii) Passed H.S. (10+2) or equivalent level with any one the following subjects:
Mathematics / Statistics / Computer Science / Computer Application / Business Economics & Mathematics (BEM) or Candidates passed in (10+2) or equivalent level with Vocational Engineering & Technology with pass marks in Additional Mathematics.
- iv) Arts / Science / Commerce graduates passing the respective degree examination (not earlier than 5 years) may also apply for being considered against very limited number of seat(s).

9. For BBA:

- i) The candidate must be Indian National.
- ii) Candidates must have passed the Higher Secondary Examination of West Bengal Council / I.S.C. Examination / C.B.S.E. Examination / Any other equivalent Examination each under (10+2) system or equivalent level of studies, as the case may be, with English as one of the combination
- iii) Students of any stream (Science, Arts, Commerce, Vocational etc.) are eligible to apply.
- iv) Arts / Science / Commerce graduates passing the respective degree examination (not earlier than 5 years) may also apply for being considered against very limited number of seat(s).

10. COURSES FROM OTHER DISCIPLINES (Multi/Interdisciplinary):

All UG students are required to undergo 3 introductory-level courses relating to any of the broad disciplines given below. Students are not allowed to choose or repeat courses already undergone at the higher secondary level (12th class) in the proposed major and minor stream under this category.

- i. ***Natural and Physical Sciences:*** Students can choose basic courses from disciplines such as Natural Science, for example, Biology, Botany, Zoology, Biotechnology, Biochemistry, Chemistry, Physics, Biophysics, Astronomy and Astrophysics, Earth and Environmental Sciences, etc.
- ii. ***Mathematics, Statistics, and Computer Applications:*** Courses under this category will facilitate the students to use and apply tools and techniques in their major and minor disciplines. The course may include training in programming software like Python among others and applications software like STATA, SPSS, Tally, etc. Basic courses under this category will be helpful for science and social science in data analysis and the application of quantitative tools.
- iii. ***Library, Information, and Media Sciences:*** Courses from this category will help the students to understand the recent developments in information and media science (journalism, mass media, and communication)
- iv. ***Commerce and Management:*** Courses include business management, accountancy, finance, financial institutions, fintech, etc.,
- v. ***Humanities and Social Sciences:*** The courses relating to Social Sciences, for example, Anthropology, Communication and Media, Economics, History, Linguistics, Political Science, Psychology, Social Work, Sociology, etc. will enable students to understand the individuals and their social behaviour, society, and nation. Students be introduced to survey methodology and available large-scale databases for India. The courses under humanities include, for example,

Archaeology, History, Comparative Literature, Arts & Creative expressions, Creative Writing and Literature, language(s), Philosophy, etc., and interdisciplinary courses relating to humanities. The list of Courses that can include interdisciplinary subjects such as Cognitive Science, Environmental Science, Gender Studies, Global Environment & Health, International Relations, Political Economy and Development, Sustainable Development, Women's and Gender Studies, etc. will be useful to understand society.

In case of any discrepancy the decision of the appropriate authority of the university shall be final. The classes of the 1st year 1st semester of UG programmes will start from 01/08/2023 with adherence to the COVID-19 norms/protocol, issued by the Government of West Bengal/competent authority time to time.
